DAINA LEESHONE BRADLEY (described below) was advised of the identity of the interviewing Agents and the nature of the interview. BRADLEY was interviewed in the presence of her attorney, SHERRY T. WALLACE, P.C. attorney, [REDACTED]

BRADLEY was previously interviewed by Special Agent ANGELA BYERS, FBI Dallas Division on May 5, 1995. On May 16, 1995, information was provided to the FBI that BRADLEY may have remembered more details regarding the bombing, which took place on April 19, 1995, at the Federal Building located on 5th Street, Oklahoma City, Oklahoma.

BRADLEY recalled that early in the morning on April 19, 1995, she travelled to the Social Security Office, Federal Building, Oklahoma City, with her mother (victim - deceased), her two children (victims - deceased), and her sister (victim - survivor). BRADLEY recalled that at approximately 7:20 a.m., while waiting in the Social Security Office, she observed a yellow RYDER truck pull into a parking spot in front of the building on 5th Street between two cars. She advised that there were several windows in the office and she was in a position to view the front parking area on 5th Street. BRADLEY drew a diagram of where the truck was parked and recalled that it was parked there for approximately 4 - 5 minutes. BRADLEY also viewed the diagram provided by the interviewing Agents and pointed out the same general location.

BRADLEY remembered that after the RYDER truck had parked, she observed a side view of an olive-skinned, white male exit the passenger side of the RYDER truck. This unidentified man was wearing a dark blue jacket (similar to a "starter jacket"), and a baseball hat with white on the side. Upon leaving the vehicle, the man walked at a very rapid pace in a westerly direction towards Harvey.

BRADLEY is recuperating from extensive injuries, including a leg amputation she endured while pinned in the
